August 16, 2021 (E-29)	County Voter Information Guides begin to be mailed for this election. <i>Cal. Elec. Code §§ 11324, 13300.7, 13303, 13304, 13305, 14282</i>
August 30, 2021 (E-15)	Last day to register to vote for this election. <i>Cal. Elec. Code § 2102</i>
August 31, 2021 (E-14)	Close of write-in candidate filing period. <i>Cal. Elec. Code § 8601</i>
